Welcome to **Furry Paws Fort Lauderdale!**

Our facility specializes in cage-free, supervised daycare and boarding for well socialized dogs. Our trained staff will monitor safe play in our indoor/outdoor daycare areas. Our **webcam access** is available to registered clients daily from **9am-4pm**. In order ensure a safe, controlled environment; each new dog is required to complete a **Temperament Evaluation** before being allowed to use our daycare or boarding services.

Enrollment Checklist:

- ✓ Make sure your dog is at least **16 weeks of age or older**
- ✓ Submit this **Enrollment Application**
- ✓ Provide a copy of **required veterinary records** including:
 - **Proof of Neuter/Spay** (only exception is puppies under 6 months)
 - Up to date vaccinations including:
Rabies, Distemper, Parvo, Bordetella*
**If Bordetella was recently administered, you must wait seven (7) days after administration to schedule a Temperament Evaluation*
 - **Negative Fecal Exam** (within 6 months)
- ✓ Schedule a **Temperament Evaluation** (by appointment only) – *Fee is \$15*
 - Dogs attending a Temperament Evaluation must **arrive before 10am** and **stay a minimum of 6 hours** to ensure a full personality assessment
 - Puppies 8 months and younger attending a Temperament Evaluation must stay a minimum of 4 hours to ensure a full personality assessment

Once the above is completed and if your dog passes our Temperament Evaluation, you are welcome to attend daily daycare or make overnight boarding reservations-subject to availability.

FURRY PAWS LIABILITY AGREEMENT

CLIENT RELEASE OF LIABILITY AGREEMENT

This Agreement is by and between Furry Paws, LLC (hereinafter called "Furry Paws") and the pet owner whose name and signature appears below (hereinafter called "Owner").

_____ Furry Paws reserves the right to refuse service to any Owner and pet for any reason, at any time, including but not limited to: failure to provide proper enrollment forms and/or proof of vaccinations, pet not meeting enrollment requirements, pet displaying aggressive or inappropriate behavior, sudden change in pet behavior, or pet displaying sign of illness which could jeopardize the health of other pets in Furry Paws' care.

_____ Owner certifies that all information provided to Furry Paws including all known medical conditions and/or behavioral problems are accurately and fully disclosed. Owner certifies that pet is in healthy condition and has not had any contagious illness of any kind for 30 days prior to first attending Furry Paws.

_____ Owner acknowledges that there is a risk involved with cage-free daycare and boarding services and even though Furry Paws offers a controlled setting through vaccination requirements and play supervision, there is a potential for contracting an airborne virus or communicable disease or enduring an injury as a result of interacting with other pets. Owner understands the risk of illness, disease, or harm and hereby agrees to hold harmless and indemnify Furry Paws, its employees, pet owners, customers, and potential customers (Indemnified Parties) from any and all liabilities, financial or otherwise, for injuries sustained to Owner, Owner's pet, or any other property of Owner which may arise from services that are rendered by Furry Paws, or as a consequence of Owner's association with Furry Paws. Furthermore, in the event Owner's Pet is transported to or from Furry Paws by Furry Paws employees, Owner holds Furry Paws harmless in the event of injury or accident during transportation.

_____ In consideration of the services rendered by Furry Paws, Owner agrees to assume any and all liability financial or otherwise, for the behavior and health of Owner's pet arising in connection with such services. Owner waives any and all claims, actions, or demands of any nature, either foreseen or unforeseen, that Owner may have against Furry Paws, relating to the care, control, health, and safety of Owner's Pet arising in connection with the services that are rendered by Furry Paws, except to the extent caused by gross negligence, bad faith, or intentional misconduct of the Indemnified Parties.

FURRY PAWS LIABILITY AGREEMENT

CLIENT RELEASE OF LIABILITY AGREEMENT

_____ In the event of an injury, emergency, or situation where Furry Paws deems medical care necessary to the Owner's pet's health (including, but not limited to: puncture wounds, cuts, diarrhea, vomiting, etc.), Owner authorizes Furry Paws to obtain medical attention for pet from Furry Paws' preferred Veterinarian. In such event, Owner grants Furry Paws full decision-making power for medical treatment in the best interest of the pet's health and Owner agrees to pay for all medical costs endured with said medical treatment. Owner agrees to authorize Furry Paws to use Owner's card on file for medical treatment provided by Furry Paws' preferred Veterinarian. Owner agrees to hold Furry Paws' preferred Veterinarian, its agents and employees, harmless from any and all claims as a result of treatment provided to pet.

_____ In the event that Owner's pet is not picked up by Owner (or authorized party) within 15 calendar days after the pet is scheduled to depart and Owner has not been reachable by phone or email, Owner understands the pet shall be deemed to be abandoned. Owner understands that pet abandonment may be a criminal or civil violation and Owner shall be liable for all fees due in association with the abandonment.

_____ In the event of a natural disaster (e.g., hurricane, tornado, flooding, etc.), it is the Owner's responsibility to arrange for the pick-up of the Owner's pet in a timely manner in accordance with any mandatory evacuations. In the event Owner is not able to pick-up Pet, Owner understands Furry Paws will do everything possible to keep Owner's Pet safe during a natural disaster, but Furry Paws is not liable for any injury or loss sustained as a result of a natural disaster.

FURRY PAWS OVERNIGHT BOARDING / SHUTTLE POLICY

OVERNIGHT BOARDING POLICY

1. All pets using Furry Paws' boarding service must have an emergency contact available to pick up the pet in the event Furry Paws does not see itself capable of providing the necessary care as a result of a medical emergency or change in animal behavior.
**If Owner does not have a personal contact available, Furry Paws reserves the right to check-in the Owner's pet into Furry Paw's preferred Veterinary Clinic or Owner's listed Veterinary Clinic and Owner will be liable for fees incurred.*
2. All pets using Furry Paws' boarding services must provide their own food and medications. Failure to provide food may result in an additional food purchase fee.
3. Personal items (e.g., beds, blankets, toy, etc.) are allowed to be with pet while it is secure in its own crate or suite at night. **Note: Furry Paws is not responsible for personal items that are brought into the facility. Toys of any sort are not allowed in the daycare/boarding area during normal operating hours.*
4. Any pet staying at Furry Paws for duration of five (5) nights or more will be subject to a 50% payment deposit upon check-in.
5. Any pet who is boarding and does not have a form of payment on file will be required to pay the full amount of the entire boarding stay in advance of their stay.

SHUTTLE POLICY

1. All shuttles are by appointment only and must be booked during available slots offered by Furry Paws staff. Slots will be designated in half hour intervals Monday – Friday from 8:00am-10:00am and 5:00pm-7:00pm, Saturdays and Sundays from 8:30am-10:00am and 4:30pm – 6:00pm.
2. A Furry Paws staff member will notify you by phone ahead of time if there will be any delays in having your pet dropped off or picked up at your scheduled time.
3. For customers living in buildings of three (3) or more floors, there will be an additional \$2 fee if you require the Furry Paws driver to drop-off your pet at your door step. ** This fee will not apply if you meet the Furry Paws driver curb side.*
4. All shuttle pricing is subject to change and will be determined by the Furry Paws Shuttle Zoning Chart.
